### Inhalation:

## 6. ACCIDENTAL RELEASE MEASURES

### **Emergency procedures/Environmental precautions:**

Shut off all possible sources of ignition. If contamination of sewers or waterways has occurred advise local emergency services.

### Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. After cleaning, flush away any residual traces with water and detergent.

## 7. HANDLING AND STORAGE

**Precautions for safe handling:** Avoid skin and eye contact and breathing in vapour, mists and aerosols. Wash hands thoroughly after handling.

**Conditions for safe storage, including any incompatibilities:** Store in a cool, dry, well ventilated place and out of direct sunlight. Recommended storage temperature: 15°C to 25°C. Store away from sources of heat or ignition. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.

WES - TWA (Workplace Exposure Standard - Time Weighted Average) - The eight-hour, time-weighted average exposure standard is designed to protect the worker from the effects of long-term exposure.

These Workplace Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These workplace exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

### Appropriate engineering controls:

Ensure ventilation is adequate and that air concentrations of components are controlled below quoted Workplace Exposure Standards. Vapour heavier than air - prevent concentration in hollows or sumps. DO NOT enter confined spaces where vapour may have collected. Keep containers closed when not in use.
