Dike far ahead of spill to collect runoff water. Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal.

**Methods for cleaning up** Slippery when spilt. Avoid accidents, clean up immediately. Dam up. Soak up with inert absorbent material. Use personal protective equipment as required. Pick up and transfer to properly labelled containers. After cleaning, flush away traces with water and detergent.
