4. FIRST AID MEASURES

Inhalation:

6. ACCIDENTAL RELEASE MEASURES

Emergency procedures/Environmental precautions:

If contamination of sewers or waterways has occurred advise local emergency services.

Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

7. HANDLING AND STORAGE

Conditions for safe storage, including any incompatibilities: Store in a cool, dry, well ventilated place and out of direct sunlight. Store away from sources of heat or ignition. Store between 15°C and 25°C. Protect from air. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.

WES - TWA (Workplace Exposure Standard - Time Weighted Average) - The eight-hour, time-weighted average exposure standard is designed to protect the worker from the effects of long-term exposure.
