**Methods and material for containment and cleaning up**

**Methods for containment** Stop leak if you can do it without risk. Remove ignition sources. Provide adequate ventilation. Keep out of drains, sewers, ditches and waterways. Soak up condensate with inert absorbent material and collect in ventilated waste container for disposal.

**Methods for cleaning up** Slippery when spilt. Avoid accidents, clean up immediately. Cover with damp absorbent(inert material, sand or soil). Vacuum or sweep material and place in a disposal container. Use non-sparking tools. Avoid generation of dust. Use personal protective equipment as required. Pick up and transfer to properly labelled containers. For the molten material: Contain - prevent run off into drains and waterways. Allow material to solidify.
