4. FIRST AID MEASURES

Inhalation:

Personal precautions/Protective equipment/Methods and materials for containment and cleaning up: Wear protective equipment to prevent skin and eye contact and breathing in dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust.
