**Specific hazards arising from the chemical** Non-combustible. However following evaporation of the water component of the material, the residual material can burn if ignited. **Methods for cleaning up** Slippery when spilt. Avoid accidents, clean up immediately. Dam up. Soak up with inert absorbent material. Use personal protective equipment as required. Pick up and transfer to properly labelled containers.
