### **Methods and material for containment and cleaning up**

**Methods for containment** Stop leak if you can do it without risk. Remove ignition sources. Provide adequate ventilation. Dike far ahead of spill to collect runoff water. Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal.

**Methods for cleaning up** Slippery when spilt. Avoid accidents, clean up immediately. Dam up. Use non-sparking tools. Soak up with inert absorbent material. Pick up and transfer to properly labelled containers.

## **7. HANDLING AND STORAGE**

### **Precautions for safe handling**

**Advice on safe handling** Avoid contact with skin and eyes. Avoid breathing vapors or mists. Ensure adequate ventilation. Keep away from open flames, hot surfaces and sources of ignition. Take precautionary measures against static discharges. Wash thoroughly after handling. Use personal protection equipment. Use according to package label instructions. Handle in accordance with good industrial hygiene and safety practice.
