Clear area of all unprotected personnel. If contamination of sewers or waterways has occurred advise local emergency services.

Wear protective equipment to prevent skin and eye contact. Avoid breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways.
