## 4. FIRST AID MEASURES

#### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

# 5. FIRE FIGHTING MEASURES

#### Suitable Extinguishing Media:

Fine water spray, normal foam, dry agent (carbon dioxide, dry chemical powder).

#### Specific hazards arising from the chemical:

Combustible material.

#### Special protective equipment and precautions for fire-fighters:

On burning will emit toxic fumes, including those of oxides of carbon . Heating can cause expansion or decomposition of the material, which can lead to the containers exploding. If safe to do so, remove containers from the path of fire. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

#### **Emergency procedures/Environmental precautions:**

#### Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. Use non-sparking tools.

**Precautions for safe handling:** Avoid skin and eye contact and breathing in vapour, mists and aerosols. Wash hands thoroughly after handling.

**Conditions for safe storage, including any incompatibilities:** Store in a cool, dry, well ventilated place. Store below 40°C. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.
