## 4. FIRST AID MEASURES

### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Seek medical advice if effects persist.

### Skin Contact:

## 6. ACCIDENTAL RELEASE MEASURES

### Emergency procedures/Environmental precautions:

Clear area of all unprotected personnel. Do not allow container or product to get into drains, sewers, streams or ponds. If contamination of sewers or waterways has occurred advise local emergency services.

### Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Neutralise with sodium bisulphite. Collect and seal in properly labelled containers or drums for disposal.
