### 4. FIRST AID MEASURES

#### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

## 5. FIRE FIGHTING MEASURES

### Suitable Extinguishing Media:

Dry agent (dry chemical powder).

### **Unsuitable Extinguishing Media:**

Water.

### Specific hazards arising from the substance or mixture:

Non-flammable. May evolve flammable hydrogen gas on contact with oxidising agents, acids and alkalis. Reacts slowly with water to liberate flammable hydrogen gas. Avoid all ignition sources. All potential sources of ignition (open flames, pilot lights, furnaces, spark producing switches and electrical equipment etc) must be eliminated both in and near the work area. Do NOT smoke.

### Special protective equipment and precautions for fire-fighters:

Decomposes on heating emitting toxic fumes, including those of aluminium oxide. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion. Reacts slowly with water to liberate flammable hydrogen gas.

### 6. ACCIDENTAL RELEASE MEASURES

### Emergency procedures/Environmental precautions:

Clear area of all unprotected personnel. Shut off all possible sources of ignition. Wear protective equipment to prevent skin and eye contact and inhalation of vapours/dusts. If contamination of sewers or waterways has occurred advise local emergency services.

### Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Avoid breathing in dust. Work up wind or increase ventilation. Wear protective equipment to prevent skin and eye contact and breathing in vapours/dust. Sweep up but avoid generating dust and airborne material. Collect and seal in properly labelled containers or drums for disposal.

### 7. HANDLING AND STORAGE

**Precautions for safe handling:** Avoid skin and eye contact and breathing in dust. Avoid formation and build up of dust.

**Conditions for safe storage, including any incompatibilities:** Store in a cool, dry, well ventilated place. Store away from sources of heat or ignition. Store away from incompatible materials described in Section 10. Protect from moisture. Keep containers closed when not in use - check regularly for spills.

WES - TWA (Workplace Exposure Standard - Time Weighted Average) - The eight-hour, time-weighted average exposure standard is designed to protect the worker from the effects of long-term exposure.

These Workplace Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These workplace exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

### Appropriate engineering controls:

Ensure ventilation is adequate and that air concentrations of components are controlled below quoted Workplace Exposure Standards. Keep containers closed when not in use.
