Conditions for safe storage, including any incompatibilities: Store in a cool, dry, well ventilated place. Store between 10°C and 35°C. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Methyl alcohol: WES-TWA 200 ppm, 262 mg/m³; WES-STEL 250 ppm, 328 mg/m³, skin, bio, BEI 15mg/L (in urine)

WES - TWA (Workplace Exposure Standard - Time Weighted Average) - The eight-hour, time-weighted average exposure standard is designed to protect the worker from the effects of long-term exposure.

WES - STEL (Workplace Exposure Standard - Short Term Exposure Limits) - The 15 minute average exposure standard. Applies to any 15 minute period in the working day and is designed to protect the worker against adverse effects of irritation, chronic or irreversible tissue change, or narcosis that may increase the likelihood of accidents. The WES-STEL is not an alternative to the WES-TWA; both short-term and eight-hour, time-weighted average exposures should be determined.

Skin' Notice - absorption through the skin may be a significant source of exposure. The exposure standard is invalidated if such contact should occur.

'bio' - Biological Exposure Index.

These Workplace Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These workplace exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.
