# **3. COMPOSITION AND INFORMATION ON INGREDIENTS**

### **Product Description:**

Alcohols, C16-18, ethoxylated propoxylated, 10-<30% Dimethylpolysiloxane hydrolyzate, 3-10% Polyether-modified polydimethylsiloxane (CAS No. 64365-23-7), <10% Other component(s), to 100%

## 4. FIRST AID MEASURES

#### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If patient finds breathing difficult and develops a bluish discolouration of the skin (which suggests a lack of oxygen in the blood - cyanosis), ensure airways are clear of any obstruction and have a qualified person give oxygen through a face mask. Apply artificial respiration if patient is not breathing. Seek immediate medical advice.

#### Skin Contact:

If skin or hair contact occurs, immediately remove any contaminated clothing and wash skin and hair thoroughly with running water and soap. If swelling, redness, blistering or irritation occurs seek medical assistance.



## Eye Contact:

If in eyes, hold eyelids apart and flush the eye continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre or a doctor, or for at least 15 minutes.

#### Ingestion:

Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water. Never give anything by the mouth to an unconscious patient. Seek medical advice.

#### Indication of immediate medical attention and special treatment needed:

Treat symptomatically.

# **5. FIRE FIGHTING MEASURES**

#### Suitable Extinguishing Media:

Not combustible, however, if material is involved in a fire use: Normal foam, dry agent (carbon dioxide, dry chemical powder).

#### Unsuitable Extinguishing Media:

Solid water jet/stream may scatter and spread the fire.

#### Specific hazards arising from the chemical:

Non-combustible material. Decomposes on heating emitting toxic fumes.

## Special protective equipment and precautions for fire-fighters:

Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to products of decomposition.

## 6. ACCIDENTAL RELEASE MEASURES

### **Emergency procedures/Environmental precautions:**

Clear area of all unprotected personnel. Do not allow container or product to get into drains, sewers, streams or ponds. If contamination of sewers or waterways has occurred advise local emergency services.

## Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

## 7. HANDLING AND STORAGE

**Precautions for safe handling:** Avoid skin and eye contact and breathing in vapour, mists and aerosols. Wash hands before breaks and at the end of the work day.

**Conditions for safe storage, including any incompatibilities:** Store in a cool, dry, well ventilated place. Store between 5°C and 40°C. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.
