## 2. HAZARDS IDENTIFICATION

## **3. COMPOSITION AND INFORMATION ON INGREDIENTS**

Product Description: Calcium ferro mixture covered by steel sheath, 100%.

### 4. FIRST AID MEASURES

### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek immediate medical advice.

### Skin Contact:

If skin contact occurs, remove contaminated clothing and wash skin with soap and water. If irritation occurs, seek medical advice.

### Eye Contact:

If in eyes, wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.

### Ingestion:

Rinse mouth with water. If swallowed, give a glass of water to drink. Never give anything by the mouth to an unconscious patient. Seek medical advice.

## **5. FIRE FIGHTING MEASURES**

### Suitable Extinguishing Media:

Dry agent (carbon dioxide, dry chemical powder), sand or earth.

### Specific hazards arising from the chemical:

Non-combustible material.

### Special protective equipment and precautions for fire-fighters:

Decomposes on heating emitting toxic fumes, including those of oxides of iron. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to products of decomposition.

## 6. ACCIDENTAL RELEASE MEASURES

### Emergency procedures/Environmental precautions:

Clear area of all unprotected personnel. If contamination of sewers or waterways has occurred advise local emergency services.

### Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Avoid breathing in dust. Work up wind or increase ventilation. Wear protective equipment to prevent skin and eye contact and breathing in vapours/dust. Sweep up but avoid generating dust and airborne material. Collect in properly labelled containers for disposal.

## 7. HANDLING AND STORAGE

Precautions for safe handling: Avoid skin and eye contact and breathing in dust.

**Conditions for safe storage, including any incompatibilities:** Store in a cool, dry, well ventilated place. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for spills.

### 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

WES - TWA (Workplace Exposure Standard - Time Weighted Average) - The eight-hour, time-weighted average exposure standard is designed to protect the worker from the effects of long-term exposure.

These Workplace Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These workplace exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.
