CAUTION: Do not pack column with dry ion exchange resins. Dry beads expand when wetted; this expansion can cause glass column to shatter. Avoid contact with skin and eyes. Avoid generation of dust. Fine dust dispersed in air, in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard. Take precautionary measures against static discharges. Use grounding and bonding connection when transferring this material to prevent static discharge, fire or explosion. If product is frozen allow it to thaw.
