The International Agency for Research on Cancer (IARC) have concluded that occupational exposure to strong inorganic acid mists containing sulphuric acid is carcinogenic to humans, causing cancer of the larynx and to a lesser extent, the lung. No direct link has been established with sulphuric acid, itself, and cancer in humans. Exposure to any mist or aerosol during the use of this product should be avoided and exposure should not exceed the exposure standard. Available evidence indicates that exposure to strong inorganic acid mists containing sulphuric acid may produce erosion and discolouration of teeth.
